re-enrollment</u> | Enrollment/re-enrollment Paperwork complete and turned in to the VCA office along with: \$200 enrollment/re-enrollment fee. |
| <u>5/16/2017 - Registration:</u> | Registration fees due (\$400/child, \$350 for 3 rd child, \$0 for each child thereafter). The \$200 Enrollment/re-enrollment Fee already paid in March will be deducted from your Registration Fee at that time. |

Financial Aid will once again be available for those of you who apply by the deadline and qualify. Your timely enrollment/re-enrollment is a crucial part of our planning process, as teachers and other support staff need to have accurate enrollment/re-enrollment numbers as we move toward finalizing our needs in order to make 2017-2018 a successful year at VCA. As stated above, **enrollment/re-enrollment requirements must be turned in to the VCA office no later than February 28, 2017.**

The last milestone to which attention needs to be drawn is the final Registration deadline of May 16, 2017. This is when your Registration fee of \$400 per child (\$350 for 3rd child, \$0 for each child thereafter) is due. The \$200 Enrollment/re-enrollment Fee already paid in March will be deducted from your Registration Fee at that time.
